This multi-national force of more than 33,000 men and women redefined the concept of valor to meet the unique demands of counterinsurgency operations, combining selfless courage in the face of a lethal enemy with unprecedented restraint and military effectiveness. Displaying unparalleled tenacity, the Marines, Soldiers, Sailors, and Airmen confronted insurgents daily, eliminating more than 2,000 and capturing and detaining at least 6,600 while sustaining 308 friendly killed-in-action and 3,134 wounded. Boldly moving to deny insurgent footholds, I MEF systematically established combat outposts in the most dangerous sections of nine critical cities, and then used physical barriers and biometric technology to maintain control of the population and deny insurgents freedom of movement.
